MESSAGE FROM OUR PRESIDENT

Fueled by local donors, local volunteers, a local board of directors, and local staff, we are creating significant impact, right here in Olmsted County and Southeast Minnesota. We are grateful for our collective ability to envision and make change possible—that's Living UNITED.

By investing in United Way of Olmsted County, you impact a wide range of needs and help to change the odds for local individuals and families. Creating a healthier community and helping individuals reach their potential begins with donors, volunteers, and advocates like you.

Demand for basic services like food, housing, mental healthcare, and other support remain at elevated levels following the historic spike during the pandemic. Those experiencing systemic inequities have been hit harder and for longer durations than others.

During the past year, United Way of Olmsted County continued our efforts to ensure holistic, integrated supports are available for individuals and families when they need them. United Way plays a unique role in our community, bringing together specific services offered by community partners in novel ways to fill gaps and support the whole person. For examples, see our Meadow Park Initiative and Community Schools Partnership web pages.

To better address rising needs in our community, in July 2021, the United Way of Olmsted County Board of Directors authorized a major plan to expand our ability to connect individuals in our community with our mission. This past year, we expanded opportunities for individuals to give, advocate, and volunteer. One example is the 21-Day Equity Challenge; nearly 2,000 individuals participated in this unique experience designed to deepen awareness of inequities in our community, the systems that hold them in place, and what we can do collectively to make Olmsted County a place where all people can reach their full potential.

Inspired by United Way's mission and the collective power of our community, our donors went the extra mile to encourage others to get involved.

The 2021 Give United Drawing was created in partnership with Rochester Motor Cars to offer participants a fun twist and opportunity to win a two-year lease on a vehicle from Rochester Motor Cars. We are thankful for Rochester Motor Cars and their lease donation. Due in part to the Give United Drawing, we welcomed nearly 1000 new donors to United Way in 2021.

The Leadership Challenge Match was made possible by a coalition of corporate and individual donors, including: Scheels, Think Bank, Knutson Construction, Elaine Case and Bill Wiktor, Ron Menaker and Linda Mansfield, Kasten/Bible Family and an anonymous donor. The \$70,000 matching fund was created to encourage individuals to the next level of giving and I am delighted to report it was successful in encouraging others to increase their donations.

We are very grateful for our partnerships with local companies and private citizens to create this occasion to multiply their contributions.

By combining contributions from thousands of donors and partnering with nonprofit programs to offer integrated solutions to a wide range of human needs, we meaningfully touched over 48,000 lives in our community last year.


The United Way of Olmsted County Board of Directors recognizes equity as a core value that is critical in achieving United Way's mission. We value the intentional inclusion of everyone in our community.

We strive to dismantle systemic, institutional, and historical barriers based on race, ethnicity, ability, and other identities so they no longer determine socioeconomic, education, and health outcomes.

Our mission compels us to prioritize people in our community who have been marginalized and excluded. United Way of Olmsted County is committed to finding and implementing community-driven solutions that ensure all people have the resources and opportunities needed to reach their full potential. We commit to leveraging all our strategies, investments, and partnerships to build a more equitable community.

Here are some of the steps we took in 2021 to meet that commitment and realize our vision of a community where all people can thrive:

- Launched our community's first-ever **21-Day Equity Challenge**. The 21-Day Equity Challenge is a powerful opportunity for shared learning, action, and growth. Almost 2,000 Minnesotans took the challenge in 2021.
- Together with our partners, we created the **Commitment to Action Towards Racial Justice** grant fund, investing more than \$30,000 to help local organizations to take meaningful action steps toward racial justice within their organizations and the communities they serve.
- Continued our commitment to supporting culturally specific organizations (CSOs)—those organizations that serve and
 are led by people of color, immigrants, or people with disabilities. We invested more than \$225,000 in such
 organizations last year, representing approximately 18% of our total grant awards.
- Began our **Culturally Powered Communities** (CPC) program to support Olmsted County's diverse cultural communities by strengthening the organizations that serve them.
